While the database used in the presentation will be PowerSchool, the majority of the concepts could be applied to any database. Throughout the presentation, specific PowerSchool ironies will be provided so that the user can participants do not use PowerSchool, access to a test server will be provided so that the user can participate in the workshop. The knowledge of SQL has revolutionized how data is managed within the Annville-Cleona School District. It has opened up many different doors to allow the replacement of manual processes with automated ones, as well as provide the opportunity to integrate into different applications. A few examples include automating student account creation (this involves knowledge of powershell), providing detailed CSV dumps for vendors that extend beyond what PowerSchool can natively do, and finding/fixing errors that affect PIMS (State Reporting).
